There is a popular maxim in common law systems, "everything which is not forbidden is allowed". The idea is that in liberal democracies we are inherently and naturally free to do anything, so long as it is not expressly prohibited by law.

The opposite principle "everything which is not allowed is forbidden" states that an action can only be taken if it is specifically allowed.

A senior English judge, Sir John Laws, stated the principles as:

"For the individual citizen, everything which is not forbidden is allowed; but for public bodies, and notably government, everything which is not allowed is forbidden."<sup>[3]</sup>
